Under Jajpur Road Mining Circle.

Sub: Working of mines in areas treated as '**non-forest**' though recorded as forest in the Govt. record on or after the day the F(C) Act. came into force.

Sir,

All of you are aware of Guidelines communicated by MoEF & CC, Govt. of India vide letter No. F. No. 8-78/1996-FC (Pt.), Dt. 10.03.2015 regarding obtaining prior approval of Central Govt. under F(C) Act. 1980 in respect of land treated as '**non-forest**' included in the mines which was recorded as forest in Govt. records on or after the day the F(C) Act. came into force. Concerned User Agencies were allowed time not exceeding one year i.e. upto 09.03.2016 to continue mining operation in such areas so as to obtain prior approval Central Govt. within the said period for continuance of mining operation in their mines beyond 09.03.2016. But none of lessees has yet reported anything about the action taken in this regard in respect of their mines.

You are hereby informed to stop raising and transportation of minerals in respect of your mines w.e.f. 10.03.2016 in case you fail to obtain prior approval of Central Govt. under F(C) Act. in respect of land treated as '**non-forest**' which was recorded as forest in Govt. records on or after the day the F(C) Act. came into force within the above time.

If any mine is not affected by the above referred guidelines, the concerned lessee should please submit the necessary information for consideration of their issues in the matter of raising and transportation of minerals from their mines beyond 09.03.2016.
