- Procedure of Forward Auctioning
- 9. Online English Forward (no ties) Auction:

SAURASHTRA CEMENT LTD will declare its Starting Price (SP) & minimum increment amount, which shall be visible to the all bidders during the start of the forward Auction. Also, please note that the first bid that comes in the system should be minimum to the start price or more than the start price for each Lot. The second online bid and onwards for any particular Lot will have to be higher than the H1 rate by one minimum increment value, or higher than the increment value.
